# REQUEST FOR PROPOSAL FOR CONSULTANCY SERVICES TO SUPPORT PRODUCTIVE USE OF ENERGY (PUE).

MUCOBADI- ICARE Activity seeks proposals from energy firms for Carrying out consultancy services to support Productive Use of Energy.

Terms of Reference for Consultancy Services to Support Productive Use of Energy (PUE) Integration and Capacity Building under the USAID/ICARE Project

#### 1. Introduction

Multi-Community Based Development Initiative (MUCOBADI), founded in 2000, is a local NGO dedicated to supporting communities, especially those affected by HIV, to improve health and productivity. Registered as an NGO and incorporated as a company limited by guarantee, MUCOBADI operates with the vision of "A Self-Sustaining Healthy Community" and the mission of "Partnering with communities to identify, analyze, and respond to socio-economic barriers of the most vulnerable." With interventions across over 1/4 of Uganda's districts, MUCOBADI serves areas in Bugiri, Namayingo, Bugweri, Iganga, Mayuge, Jinja, Kamuli, and beyond.

MUCOBADI is an implementing partner for the **USAID/Improving Care and Resilience for Children and Youth Activity (USAID/ICARE)** in East Central Uganda. This project works to prevent new HIV infections and reduce vulnerability among Orphans and Vulnerable Children (OVC) and their caregivers. Key outcomes include enhanced identification, retention, and viral suppression among HIV-positive children and adolescents, along with improved health outcomes for vulnerable youth.

# 2. Technical Background

Since 2000, the Government of Uganda, with development partner support, has expanded rural electrification, increasing connections to the national grid from 6% in 2006 to 19% in 2023. Currently, however, only 5.2% of the rural population has access to electricity, compared to 57.2% in urban areas. Off-grid solar photovoltaic solutions have since emerged as a viable alternative, especially for last-mile, cost-effective rural access, given reduced prices, innovative products, and accessible payment systems.

Despite the shift to solar energy, rural adoption has largely been limited to basic lighting rather than productive uses, such as agro-processing or improved healthcare services. Programs like USAID's Power Africa aim to address this gap, supporting rural communities, especially vulnerable groups and women-led businesses, by expanding the productive use of energy (PUE) for economic growth and better health outcomes. A 2022 survey by the Lawrence Berkeley National Laboratory revealed that women-led businesses with access to electricity demonstrated low adoption of PUE functions, with 81% of women expressing interest in efficient PUE equipment to expand their businesses. Despite this, financing for PUE solutions remains limited, with 48% of women never having received loans to finance such connections. In agriculture, women, though making up over half of Uganda's agricultural workforce, often have lower productivity than men due to limited resources and access to modern equipment.

In the health sector, women and youth are disproportionately affected by HIV. According to the Uganda AIDS Commission, 61% of those living with HIV are women, resulting in an increased number of OVC. PUE could help alleviate the burden of caregiving for HIV-affected households by enhancing income-generating opportunities and supporting efficient, time-saving energy applications in both household and business settings.

USAID/Uganda works with over 500,000 individuals impacted by HIV, including OVC, caregivers, and community members engaged in agriculture as their primary livelihood. Studies indicate that extending electricity access can substantially improve agricultural productivity by enabling mechanized post-harvest processing, reducing losses, and enhancing product quality. These benefits can lead to greater income generation and contribute to economic growth in rural Uganda.

A report by the Rocky Mountain Institute estimates that the potential revenue from agricultural productivity and processing in rural areas could reach \$4 billion by 2025 through the use of electricity, with an annual revenue potential of \$22 million.

# 3. The ICARE Activity

MUCOBADI implements the **USAID/ICARE** project in East Central Uganda, targeting 47,871 OVC and caregivers across 10 districts of Jinja, Kamuli, Mayuge, Bugiri, Iganga, Bugweri, Namayingo, Buikwe, Kayunga, Mukono, and Jinja city. ICARE's primary goals are to prevent new HIV infections, reduce vulnerability, and improve health and resilience for OVC and caregivers. Key interventions focus on strengthening HIV services, enhancing adolescent health, and preventing violence against children and youth.

This RFP outlines activities under **Sub Result 2.2: Increased Access to Education, Business Development, and Entrepreneurship Skills for High-Risk Adolescents**. These efforts will support MUCOBADI's goal of integrating clean energy into ICARE programming, thereby enhancing the economic livelihoods of OVC, caregivers, and community members.

# 4. Planned Activity

MUCOBADI has secured Power Africa funding to integrate productive energy use (PUE) in the agriculture and health sectors within the USAID/ICARE Activity. Through this activity, MUCOBADI aims to stimulate economic transformation by promoting PUE applications in agriculture and health for income generation and improved quality of life. The activity will be implemented in the 10 districts and one city.

# 5. Objectives

The consultancy firm engaged for this project will work closely with the **ICARE senior leadership** team and **Technical Advisors** to achieve the following objectives:

- 1. **Promote last-mile solar PUE distribution** through partnerships with women-led groups in agriculture and health sectors.
- 2. **Integrate youth**—particularly those affected by HIV—into the off-grid solar supply chain through Village Savings and Loan Associations (VSLAs) and partnerships with solar entities.
- 3. **Equip farmer and women groups** with skills to support last-mile solar penetration and pilot business models adoptable by off-grid entities.
- 4. **Develop an energy-as-a-service model** for cooperatives in the agricultural value chain to encourage PUE adoption.

#### 6. Detailed Tasks

**Task A:** Advance energy access to support women and youth in business, income diversification, and health improvements, especially for HIV-affected households.

- **Identify and work with 3 women and youth-led** cooperatives to promote PUE through solar solutions.
- Train cooperative management on PUE integration in their business models.
- **Facilitate matchmaking** with solar vendors and financial institutions through exhibitions, matchmaking sessions, and market days.

**Task B:** Collaborate with five established farmer cooperatives (including those with members affected by HIV) to demonstrate the viability of cooperatives as channels for last-mile solar PUE distribution in the dairy and grain sectors.

- **Develop a market approach** for off-grid PUE solutions tailored to cooperative structures.
- Support three cooperatives in structuring an energy-as-a-service business model with an Energy Service Company (ESCO), enabling solar-powered solutions for production and processing.

**Task C:** Build the resident capacity of ICARE staff to ensure the sustainability of the PUE integration project.

- Train the ICARE team on PUE and solar energy applications relevant to agriculture and health
- **Develop training materials** for continuous staff learning on clean Renewable Energy and productive Use of energy.

Task D: Develop a Monitoring, Evaluation, Accountability, and Learning (MEAL) framework against which output performance will be evaluated

• **Integrate MEAL components** specific to energy utilization, economic outcomes, and health impact tracking.

**Task E:** Develop a set of recommendations for MUCOBADI in support of PUE institutional integration

# 7. Expected Deliverables

The consultant will be responsible for preparing and submitting the following deliverables:

- **Technical Proposal:** A comprehensive plan detailing the approach, methodology, and resources to be used in the assignment.
- Financial Proposal: A clear budget with itemized costs associated with each project activity.
- Inception Report: This will include an initial assessment, project plan, and a detailed Monitoring and Evaluation (M&E) Plan outlining how the project's progress and success will be measured.

#### 10. Branding and Marking Plan

Offerors must prepare and submit a **Branding and Marking Plan** as part of the technical proposal in response to this request for proposals. This plan should adhere to USAID's branding guidelines and outline how the project's brand will be represented across all deliverables.

# 11. Acceptance and Reporting Criteria

The consultant will report directly to the Deputy Chief of Party (DCOP) of ICARE, with ongoing support from MUCOBADI's PUE Advisor. All deliverables will be reviewed by MUCOBADI, which will provide feedback and final approval within one week of submission. To facilitate efficient execution, the consultant may propose implementing certain components of the assignment concurrently where feasible.

# 12. Qualifications and Experience

The consultancy firm selected for this project must meet the following qualifications:

- 1. **Experience in the Energy Sector:** At least 5 years of experience working in the energy sector, with specific knowledge of Uganda's rural electrification agenda.
- 2. **Previous PUE Assignments:** Proven experience in implementing at least 5 PUE assignments over the past five years within Uganda, including two assignments funded by USAID Power Africa. This experience should be detailed, with references, in the past performance section of the technical proposal.
- 3. Physical Presence in Uganda: The firm must have an established office in Uganda.
- 4. **Client References:** Provide a minimum of three reference letters from clients for similar scopes of work (SOW).
- 5. **Experience with Cooperatives and Associations:** Demonstrated experience working with groups, cooperatives, or associations within Uganda.
